MESSAGE FROM THE PRESIDENT – Michael Moore

Dear colleagues,

I hope this finds you well and that many of you were able to take some leave during the most recent school-holiday period. My personal thanks to Dorothy Francis for being acting-President while I was overseas. We have had two EC meetings since the last newsletter, including one on the 19.5. I hope the following feedback is helpful.

Financially, we appear to be on budget which is reassuring. However, we don't have sufficient funds at present to attend to the roof repairs, which is a priority for the premises. Our Treasurer, Jan Williams, will be circulating an invitation for donations again if she hasn't done so already. We were very grateful last year for the money generously donated. We also thank everyone that has been able to, for their payment of fees before June 30. It makes a big difference.

Other **premises** news includes congratulations to Maria Kourt for managing to sell our surplus bookcases to a good home. We do have some available sessions for the consulting room – it would be great to keep this in mind for colleagues enquiring about rooms.

The Membership Board (Belinda Keatinge, Maria Kourt and Donna Jacobs) continue to review many of our processes. The current focus is on clarifying the criteria for Associate Membership which is near completion. This is very timely and relevant as we have ongoing interest from external professionals hoping to join us, a very encouraging trend.

Our **Peer Group Pod** (Natasha Bonnin, Jo Barnes and Donna Jacobs) has been very active. Please look out for the letter describing the next steps of their work, which includes the idea of Case Conferences by peer groups as a way of sharing our interest in clinical work and integrating the peer groups with the

membership as a whole. A pilot experience is planned for May 30.

Jo Coulthard and Natasha Bonnin have formed a **Website pod** and have been doing some serious and much needed work on it this year. Please look it up if you haven't lately to see the changes. The problems logging-on are taking some fixing – but please contact them directly through Lyndall if you are having any difficulties. Behind the scenes they have ensured that we can now quickly and directly post things like journal articles or update content. At a later stage, we plan to have another meeting to take people through the updated website.

The EC is continuing to coordinate **CPD** activities. Donna Jacobs may have already presented on the 28.5, "On running a mothers' group for young Aboriginal mothers and their children", by the time this newsletter goes out. In April many of us were able to catch-up over a very enjoyable lunch at the Welcome Hotel. Coming up: In June, Julia Meyerowitz-Katz from the Jungian Society discussing note-taking and some of the ethical, clinical and medico-legal issues involved. In August there is another Social event planned: the play "Torch Song Trilogy" at Darlinghurst on a Sunday afternoon, to be followed by dinner at The Common Eating House nearby. We have a number of other activities in the pipeline for the second half of the year – more soon. Our thanks to all the EC but particularly Dorothy and Natasha for their energy and ideas.

Planning is well underway for the **Dadirri weekend** (Nov 24). Gill Straker has generously agreed to be our Saturday group facilitator. Please note that this year, we have decided to base the weekend in Sydney, at the premises and nearby. We hope that this will make it easier for more people to attend, for all or part of the experience.

Many of us will be at the annual **PPAA Conference** in a couple of weeks. For those attending, it will be a good chance to become more informed about the

progress towards the PPAA joining a new Confederation of psychoanalytic organisations, which is imminent. There is another Trainee conference being organised – more registrations would be good, and it is not too late to encourage or enquire after the trainees you might have personal contact with about attending the conference.

With regard to the PPAA and training, please find attached, the previously circulated **Distance Training Register**. Our colleagues in APPWA (Western Australia) are planning to commence a new training group after a long pause. In order to do so successfully, they will definitely need help from other Member Associations to provide distance therapies, supervision and probably teaching. For those in a position to, I encourage you to submit the form to help APPWA plan their program.

The **training program** at NSWIPP is progressing smoothly. The 2016 group have begun their seminars following successfully completing their Infant Observation experience. There are too many people involved in the training to mention here, but I just wanted to acknowledge the work of the Progress Subcommittee on this occasion as they are preparing the biannual reports for the trainees. These reports are also circulated to the relevant Trainee Advisers and Supervisors. Whilst there should be no surprises for the trainees in these reports, we believe they are an important mirror of a trainee's overall progress, particularly their positive development. The PSC is the only body that can consider the whole picture and as such, this involves considerable work and responsibility. The current PSC is Mary Cameron and Robin Truda (co-chairs), Robin Bowles and Leonie Sullivan. Sue Fry is on leave this year but was the previous Chair. A big thank you to them.

The Reading Group is also underway again this year. Thanks needs to go to Anne-Marie and her group for continuing to organise this very important "bridging" initiative and also to all the facilitators that are freely giving of their time and expertise
