Notes from the President's Desk

Dear All,

The EGM and Purchase of the Premises:

My sincere apologies about the lack of clarity with regard to the resolution for the EGM regarding potential for purchase of the premises by NSWIPP.

This matter follows on from the last Welmix Meeting where it was decided by Unit holders that the time had come for this matter to be raised with the Membership.

Welmix was originally set up as a property trust in 2000 because NSWIPP was not at the time in a position to take out a loan, having no previous credit rating and because the Membership as a whole at the time considered that the Institute was in need of a home. It was always the intention of the Members that NSWIPP would eventually purchase the building.

Unfortunately over time this has not eventuated and a kind of two-tiered system of ownership has arisen that is clearly not in the best interests of the Institute as a whole.

There is general agreement among Welmix unit holders that the situation cannot continue indefinitely and understandably many unit holders who have been carrying units or paying interest on them for the past 14 years are now wishing to divest themselves of them.

At the same time NSWIPP is now in a sounder financial position to take over the loan.

There are of course a number of issues to consider in relation to this and we first had to discuss with the Welmix unit holders what the general feeling was before putting the matter to the Membership as a whole.

There is clearly a need for further discussion, and we intend to first circulate a discussion paper which I urge you to consider and enter into dialogue about before again coming together at a scheduled meeting to both discuss but then vote on the proposal that Members agree to the purchase of the premises by NSWIPP. We cannot go on discussing this matter indefinitely.

Dadirri Weekend: 10-12th October

Please note that we have scheduled an in-house weekend conference/retreat just for ourselves from Friday evening, 10th October to Sunday lunchtime, 12th October.

The venue is Yanada, 1741 St. Alban's Road, St. Albans.

Yanada is a very beautiful bush land Buddhist retreat centre which offers conference facilities at a very reasonable cost. Full accommodation including three meals a day, morning and afternoon tea and full conference facilities is just \$270 per person, from Friday evening to Sunday lunchtime, including free Wi-Fi and local calls and use of all equipment. The property is set on 38 acres of land, adjacent to the Yengo National Park with great walks and a pool for the hardy among us!

There is limited accommodation on site-with six double bedrooms only. Accommodation is also available in nearby St. Alban's, 2.6 km away or in Wiseman's Ferry, a 20 minute drive away. Day-only attendance at Yanada is available at a daily fee of \$50 which is inclusive of meals and use of facilities.

Please feel free to bring partners and/or children. There is a range of attractions nearby for family members to enjoy while we are meeting as a group. Conference meetings will be restricted to Members and Associate members only.

The idea of the Conference is to provide space for us to reflect as a group on where we are at the present time and where we want to be in the future as well as to come together as a group.

We will be considering the issue of our identity following on from the discussion begun at the June Inreach Meeting on what defines us as an Institute of Psychoanalytic Psychotherapy.

This is a follow on from the previous Dadirri Conference last held in 2007 and attended by 14 members. It would be good to have as many members as possible attending and hopefully we can have an enjoyable time as well as some thoughtful discussions about future directions.
