## MESSAGE FROM THE PRESIDENT – Michael Moore

Dear colleagues

Since the last newsletter, the shock and sadness of losing John Boots, is understandably affecting many of us. It was comforting to be amongst such a large number of the NSWIPP community at his funeral. I hope everyone is travelling ok.

Other **member news** includes the retirement of Lewis Rumiz. A good few of us have been expecting this for some time and Lewis will continue to be involved with NSWIPP via teaching. However, it is another passing of sorts, as Lewis has been so involved with NSWIPP life – in particular, his long and deep commitment to the training in several roles. For the PPAA, he was a past editor of the Journal, another example of his significant legacy. If he would like to, Lewis has been invited to present a valedictory talk, much like Penny Jools did some time back.

On the opposite curve of the great wheel, we look forward to Julie Fletcher presenting for Membership in September.

**Financially** we continue to hold our own quite well. We had a fantastic response to the appeal for donations: Jan Williams has thanked the individual donors in person, but I want to acknowledge their generosity collectively, as we raised around \$8000 to help with roof repairs and other maintenance. Our 'fridge is also coming to the end of its life-span: Jan and the EC wonder if anyone has a bar-fridge or similar that could be donated?

The major news regarding the **Training** is that the ATAB, with the support of the EC, has recently decided to proceed with offering a new training intake in 2019. This is both an exciting and daunting prospect but maintaining momentum is very important for the future of our organization. An example of our curriculum has been added to the website under "training".

To mention some **PPAA training** news here, APPWA is definitely proceeding with the resumption of training after many years, so those members who have filled-out the

distance training register can expect to be contacted in the near future. There is also a very cautious initiative being considered to help NZIPP repair some of the impact of their difficulties via training. By this I mean, one or two New Zealanders may be trained as distance NSWIPP trainees. It is by no means clear if this will be feasible, but time will tell.

The **Peer Group** initiative continues, having had the inaugural pilot Case Conference presented by Joanna Barnes on July 30, which was well attended and a positive experience. Natasha Bonnin is presenting at the next Case Conference on Monday August 27.

The Open Peer Group has been wound-up due to lack of numbers making it unworkable. I wish to acknowledge the efforts of Chris Fairall as the coordinator for this group, over many years.

Turning to other **professional activities**, there was a great response to the theatre night and dinner organised by Dorothy. That is, *Torch Song Trilogy*, on Sunday 5<sup>th</sup> August, at the Darlinghurst Theatre. It was an enjoyable and compelling experience which was followed by a very pleasant meal together.

A save the date flyer would have been circulated by now for the Saturday morning seminar on November 3 on Contemporary Perspectives when Sally Young from QPPA will be talking about siblings and Peter Blake from ICAPP will be talking about therapeutic processes. We plan to offer live-streaming for this activity.

The postponed seminar by Mandi Hill has been rescheduled for October 22.

Planning is in progress for this year's **Dadirri** at NSWIPP over the weekend of November 24, 25. We are basing it at Glebe this year as an alternative to going away for the weekend as we hope this will allow more members to be involved– more details soon.

We also plan to have another lunch later in the year at NSWIPP to present certificates for completion of Infant Obs, Training, attaining Membership and to acknowledge retirees.

Thanks to Jan and Anne-Marie for the maintenance of the **premises**. The consulting room is continuing to be well-used, despite an occasional car-accident outside. A working bee that involved sawing and removing the old wood from the deck as well as much tidying, rubbish removal and cleaning has taken place. We need to thank my son, Vincent and his school-friend, Deklan, for doing the bulk of this work as part of their community service activities.

**Other PPAA matters:** The Confederation has now been born, that is, the Australasian Association of Psychoanalytic Psychotherapies (the PPAA, APAS, ANZSJA and the AAGP). As well, a revitalised committee to address public issues when arising, has been formed within the PPAA, chaired by our own Laurie Lovell-Simons. To assist with this, Council has worked-through and agreed on guidelines related to position statements by the PPAA.

By way of a reminder, NSWIPP is hosting the PPAA conference next year as well as organizing the Trainee conference. Good progress has been made already for both these challenging responsibilities.

My thanks to everyone for their support of NSWIPP, and in particular, the EC and Committees. Always last but never least, thanks to Lyndall for her unfailing administrative support and calmness.
